

#### **DVPN/DVPO - Criteria**

- Perpetrator is 18 or over
- Use or threat of violence and necessity to protect from further use of or threat of violence
- To protect Associated persons spouses /partners / persons who have or have had (i.e. "Exes") /relatives/people who live or have lived in same house –as defined by section 62(3) Family Law Act 1967
- Must consider welfare of any under 18s
- Can be used where an individual is NFAd, Cautioned, RUId or Police bailed with or without conditions on a case by case basis

#### **5 Point Checklist**

- 1. They have history of breaching bail, court orders etc.
- 2. Police not yet in position to charge, so would be released with little deterrent not to breach again or with any protection for the victim even if bail conditions are considered.
- 3. The relationship with associated person is such that it may lead to further incidents or breaches.
- 4. Severity of injuries or the risk of violence and injuries warrants use of DVPN.
- 5. Any other material that justifies an application for order such as children present, repeat offences, neither party supporting, the vulnerability of the victim and those involved.
- If <u>MOST</u> of these are answered yes, then you <u>MUST</u> be considering the use of DVPN alongside any other disposal options.
